The South Shore Watershed Association (SSWA) is a registered charity group established in 2011 on the

South Shore of PEI. Our area covers the DeSable watershed, Westmoreland watershed, Tryon watershed,

Augustine Cove/Cape Traverse watershed, and the Seven Mile Bay watershed. SSWA has the mandate to

protect and enhance fish passage from estuary to headwaters; increase the diversity of native trees and

shrubs; and, connect the community with local nature by hosting events and sharing information about

the local wildlife.
